Whereas:

- a. The Author, out of natural love and affection and for the cause of charity, is desirous of creating and settling a public charitable trust for the benefit of society at large.
- b. The Author is setting apart a sum of Rs. _____ (Rupees _____ Only) to constitute the Trust Fund.
- c. The Trustees have agreed to act as the first Trustees of the Trust, upon the terms and conditions hereinafter mentioned.

NOW THIS DEED WITNESSETH AS UNDER:

1. Name of the Trust: The name of the Trust shall be "_____" Charitable Trust™.

2. Registered Office: The registered office of the Trust shall be at _____, and may be changed as the Trustees may decide.

3. Trustees: The present Trustees to the Trust are:

The number of Trustees shall not be less than 2 and not more than 7 at any time.

4. Trust Property: The Trust Fund initially shall consist of the said sum of Rs. _____, and may be augmented from time to time by donations, grants, and voluntary contributions.

5. Objects of the Trust:

The objects for which this Trust is established are:

- i. To promote and advance education among poor and needy students.

- ii. To provide medical aid and relief to the poor and deserving persons.
- iii. To provide food, shelter, and clothing to persons in need.
- iv. To advance any other charitable object as per law.

6. Powers and Duties of Trustees: The Trustees shall manage the Trust Funds, invest in permitted securities, utilize the income thereof for the objects of the Trust, and have all such powers as may be necessary for the promotion of Trust objects.

7. Accounts and Audit: The Trustees shall maintain proper books of accounts and get them audited yearly by a qualified auditor.

8. Amendment: The provisions of this Trust Deed may be amended by a unanimous decision of all the Trustees, provided the amendments are not inconsistent with the objects of the Trust and applicable laws.

9. Dissolution: Upon dissolution, all remaining Trust assets shall be transferred to another Trust or institution with similar charitable objects, in accordance with law.
